Lot owners may not own or maintain more than three (3) household pets. All lot owners shall license their pets at the Beaver Lake Association office during normal business hours. License fees: 2024 shall be \$10.00 per household pet and are good for a one-year period. Copy of vaccinations required to obtain tag. An animal control officer will patrol for unleashed household pets.

No animals or fowl, excluding customary household pets (and equine kept on Equestrian Lots,) shall be kept or maintained on BLA lots.

Beaver Lake Association Handbook Section VI Miscellaneous #3 Animal Violations:

Rule 300: No pet(s) will be permitted to run loose per BLA leash law. Unleashed household pets that have been taken into custody by BLA will have fines assessed and will need to pay these fines prior to claiming your animal. 1<sup>st</sup> Offense \$50. 2<sup>nd</sup> Offense \$75. 3<sup>rd</sup> Offense \$100. Addition Offenses \$100.00 each. Animals in custody of BLA will only be released Monday-Friday 8am-4pm during business hours.

Rule 301: No BLA animal tag \$25

Rule 302: Expired Tags \$25

Rule 303: Animal destructing property \$50 plus cost of damage

Rule 304: Kennel Fee (room/board) \$50 initial fine plus \$25 per day. If the animal is not claimed by day three (3) by 4pm, the animal becomes the property of Beaver Lake Association. Day 1: Day of pick up/boarding. Day 2: Day of boarding. Day 3: Day of boarding/ not claimed by 4pm becomes property of BLA and immediately turned over to BLA's animal rescue group for proper placement of animal. Animals in custody of BLA will only be released Monday-Friday 8am-4pm during business hours.

Rule 305: Animal bites a person \$100

Rule 306: Animal harasses other pets \$50

Rule 307: Shooting animals unless threatened by the animal \$250

Rule 308: Not current on vaccinations \$25
